Application for Temporary Noise Waiver

The Department of Environmental Protection is currently reviewing an application for a Temporary Noise Waiver as allowed under the Montgomery County Noise Control Ordinance, Chapter 31B, Section 11(a). The Department will receive comments on the application for a minimum of ten (10) days after distribution of this notice.

The Temporary Noise Waiver is being requested by Traffic engineering Service LLC on behalf of Diggin & Rigging, Inc., 6037 Buffalo Rd, Mt. Airy, Maryland. A large mobile crane will be on Hills Plaza Road behind 5454 Wisconsin Ave, Chevy Chase. The work requires the partial closure of the northbound lane of The Hills Plaza and will be done after-hours to minimize impacts to residents, pedestrians, businesses, and vehicle traffic.

The work is scheduled to occur on December 14, 2024, scheduling and weather dependent.
